    - Motion by Barry. Discussion.
    - Russell makes an amended motion, "I move that the Turkey Trot be held with an expense budget not to exceed \$15,000, with part of the proceeds, to be decided by the Board later, to be donated to Epilepsy Awareness and scholarships."
    - Discussion. All in favor.
- Budget and Financials Russell Zwerg: Review financials next meeting

- a. 2015 budget proposal: Russell Zwerg presented a multi-year report of income and expenses via overhead projector. Expecting a proposal for the next year's budget at the next meeting.
- b. Audit: Russell Zwerg consulted with 3 auditing firms and made a presentation with the overhead projector showing the comparison between the 3 firms. Russell makes a recommendation that we select Thomas Stephen & Company. Discussion. Teresa Biery makes a motion that we use Thomas Stephen & Company, an estimated cost of \$3,500-\$5,000. Kevin Hammack amends the motion to include that the scope of the audit to be determined by Russell Zwerg and Janet Jones. Seconded by Barry Bryan. All in favor.

New Business:

- Russell Zwerg and Dawn Kelly to meet to discuss past Foster and East invoices and other requests asked by Russell.
- Discussion on dead trees in the community
- Barry Bryan provides information about the Fall Festival at Alliance Methodist Church that will take place on October 25, 2014 from 9am to 3pm. Teresa Biery makes a motion that the PGNA set up a booth at the Fall Festival at a cost not to exceed \$100. Barry Bryan seconded. Discussion. All in favor.
- Barry Bryan provides information on Blue Zone Project.
- Russell Zwerg motion: "I move that the Association President be authorized to spend up to \$1,000 to consult with an independent attorney on the issue of our agreement with our property management company in general and on the \$400 'resale certificate fee / transfer fee' charged by the management company at the sales of homes in particular." Seconded by Teresa Biery. All in favor.
- Russell Zwerg motion: "I move that copies of all invoices and other items to be paid by the Association, regardless of amount, be provided to the Treasurer electronically and paid only after approval by the Treasurer. If the Treasurer has not acted on an invoice/item within 5 calendar days of that item's availability to the Treasurer, the management company may, if they feel the need, reach out to the Assistant Treasurer or President in lieu of the Treasurer." Seconded by Janet Jones. All in favor.
- Motion by Kevin Hammack to appoint Gerry Sauls to Chair the ACC Committee. Seconded by Russell Zwerg. All in favor.
- Teresa Biery motion to increase the Turkey Trot entry fee from \$15 to \$20 for individuals and from \$45 to \$50 for family of 4. Seconded by Russell Zwerg/Barry Bryan. Discussion. All in favor.

Meeting adjourned at 9:10pm

Follow up/other actions since October 7<sup>th</sup> meeting:

- PMS executed the approved contract with Race Chip Timing for the Turkey Trot October 8<sup>th</sup>
- October 13 motion by Russell Zwerg: "I move that PGNA accept the agreement proposal from Pullen, Cappuccio, Pullen, Benson, & Jones and designate this firm as the Association's primary law firm for all future matters, with the Association President authorized to speak for the Board with the firm and give a monthly report of the firm's activity to the Board." Second by Janet Jones and passed unanimously on October 13, 2014. The Board has signed a legal representation agreement with Pulman, Cappuccio, Pullen, Benson and Jones.
- Case 14-00: Motion by Russell Zwerg, "I move to instruct Susan Ross to respond to the September 26 homeowner letter that she received, in the way she feels best serves the interests of the Association, at a maximum cost to the Association of \$150." Seconded by Barry Bryan. Motion is passed October 18, 2014.
