

As you've all heard by now, another home break-in and vandalism occurred in the Park Place Neighborhood. It occurred within 100 yards of the previous crime and during the morning of a recent school break. The location and timing of the crime tends to support the theory that the criminals are homegrown and school age. As regrettable as this incident is, it has provided the Police with considerably more leads and evidence than they had after the first crime. It has also focussed attention on the ways in which the neighborhood is coming together to erase the damage done by the criminals and to prevent further crimes. The Park Place Neighborhood Association is forming their own Neighborhood Watch groups and Citizens on Patrol Groups as a result of these cowardly acts of destruction. We're very happy to see this neighborhood getting off to such a strong start. We're just sorry that it had to come as the result of crime.

For those of you that are interested in what caused the problems at North Tarrant Parkway and Hwy. 377, the signal lights were torn down by a truck with a tall load that went through the intersection. I was amazed by the aftermath of the incident. It's not often that you see a utility pole that has been shattered 25 feet up in the air (where the cable holding the signal was attached). The original plan was to have it repaired within a month of the incident. However, the widening of NTP on the Keller side of the road in interfering

with the placement of the signal light poles and may result in delays.

We do have some good news to report. The Basswood intersection at Hwy 35W is finally open!!!! The barricades were removed on October 20th. This should help to ease the congestion at Western Center & 35W. However, this means that more traffic will be using Basswood as an eastwest corridor. So be careful as you leave the neighborhood.

Another long awaited opening will occur at 10:00 a.m. on November 11th when the Summerglen Branch of the Fort Worth Public Library holds its grand opening. I hope to see a lot of you there. This area fought hard to get this Library and our City Councilperson Becky Haskin fought to keep it in the bond package as the largest branch library in Fort Worth. Please mark you calendar and make an effort to attend to show our community's support for the new library.



The First Thanksgiving **Proclamation**

On June 20, 1676, the governing council of Charlestown, MA, held a meeting to determine how best to express thanks for the good fortune that had seen their community

securely established. By unamimous vote they instructed Edward Rawson, the clerk, to proclaim June 29 as a day of thanksgiving, our first. That proclamation is reproduced here in the same language and spelling as the original.

"The Holy God having by a long and Continual Series of his Afflictive dispensations in and by the present Warr with the Heathen Natives of this land, written and brought to pass bitter things against his own Covenant people in this wilderness, yet so that we evidently discern that in the midst of his judgements he hath remembered mercy, having remembered his Footstool in the day of his sore displeasure against us for our sins, with many singular Intimations of his Fatherly Compassion, and regard; reserving many of our Towns from Desolation Threatened, and attempted by the Enemy, and giving us especially of late with many of our Confederates many signal Advantages against them, without such Disadvantage to ourselves as formerly we have been sensible of, if it be the Lord's mercy that we are not consumed, It certainly bespeaks our positive Thankfulness, when our Enemies are in any measure disappointed or destroyed; and fearing the Lord should take notice under so many Intimations of his returning mercy, we should be found an Insensible people, as not standing before Him with Thanksgiving, as well as lading him with our Complaints in the time of pressing Afflictions: The Council has thought meet to appoint and set apart the 29th day of this instant June, as a day of Solemn Thanksgiving and praise to God for such his Goodness and Favour, many Particulars of which mercy might be Instanced, but we doubt not those who are sensible of God's Afflictions, have been as diligent to espy him returning to us; and that the Lord may behold us as a People offering Praise and thereby glorifying Him; the Council doth commend it to the Respective Ministers, Elders and people of this Jurisdiction; Solemnly and seriously to keep the same Beseeching that being perswaded by the mercies of God we may all, even this whole people offer up our bodies and soulds as a living and acceptable Service unto God by Jesus Christ."







Adopt-a-Street Committee News

Dear Neighbors:

We have a serious problem in Park Glen with illegal signs. These signs are placed in the public right-of-way and/or on public property. Public property/right-of-way is defined as:

- That space within all medians in the center of streets, boulevards, etc.
- That space (in either direction) within 40 feet of a street intersection
- That space along the side of a street, between the street and the sidewalk

In sum, all that space, from one sidewalk, across a street to the other sidewalk

(This is a paraphrased excerpt from the City of Ft. Worth Sign Ordinance, Chapter 29, Section 2. The ordinance states further that even a sign placed on private property, in this case, requires the written permission of the property owner. Solely for the purposes of this ordinance, your private property begins at your house-side of your sidewalk and extends toward your house to the rear property line.)

For whatever reason, some business people and some of our resident-neighbors continue - illegally - to place signs advertising various events/activities/interests in these areas. Not only is this contrary to the City's Sign Ordinance, it is also contrary to all Park Glen Deed Restrictions. The effect is visual pollution! The consequences are both economic and aesthetic devaluation of the neighborhood and of our individual property.

So, to summarize and be specific:

- 1. Please do not place any sign along any street in Park Glen for any reason.
- 2. Please do not place a sign on any utility pole or street sign post.
- 3. Please do not place a sign within 40 feet of any street intersection.
- 4. Please do not permit businesses (realtors, renovators/ repairers) to place a sign on your property without your written permission. If you grant permission, please ensure the sign complies with your Deed Restrictions.

The Adopt-A-Street Committee is authorized by the City Development Department to assist in enforcing the sign ordinance. Committee members may therefore remove and discard (as trash) any signs illegally placed on public property or within the public right of way in Park Glen. We have also asked our Police Officers to assist us in this effort.

Please help us to keep our beautiful Park Glen beautiful.
