This year, you may vote online, by mail, by proxy, in-person at the annual meeting, or via ballot drop-off. You may vote for all or some races or even cast a vote to count toward quorum only without voting for any candidates.

To vote by <u>electronic ballot (online)</u>, please follow the instructions below:

- 1. Access the voting site by going to: https://vote.yeselections.com/PGNA The link to the voting site may also be found on the main page of ParkGlen.org.
- 2. From the Park Glen website, click on the link to the YesElections voting website.
- 3. At the YesElections site, enter your Election Code and your Voting PIN from the bottom of this page.
- 4. Click on Continue and follow the voting instructions.
- 5. Online voting closes on September 10, 2024, 7:30 PM Central time

## To vote by mail, please:

- 1. Complete the ballot on the reverse of this page
- 2. Fill out the information at the bottom of the ballot (paper ballots must be signed, per Texas law).
- 3. Place the ballot in the enclosed return envelope.
- 4. Affix a first-class stamp.
- 5. All ballots must be <u>received</u> on or before noon on September 10<sup>th</sup>, at the YesElections office (see enclosed envelope), so we suggest that you mail your ballot no later than September 2<sup>nd</sup>.

The Annual Meeting will be held in-person only at Generations Church, 8400 Park Vista Blvd (north end of Park Vista Blvd). Computers and/or tablets with Internet access will be available for homeowners to cast votes in person from 7:00 pm to 7:30 pm. Ballots may be delivered at the ballot drop-off station by 6:00 pm on September 10th at NMI's office located at 5421 Basswood Blvd (2 doors down from Premier Eye Care).

Paper ballots, as similar as possible to the "absentee ballot" sent out by YesElections, will be available as a backup to online voting and must be signed (per Texas Property Code 209.0058). Copies of candidate filing statements will also be available. Assuming quorum is met, results will be made known at or after the meeting.
